

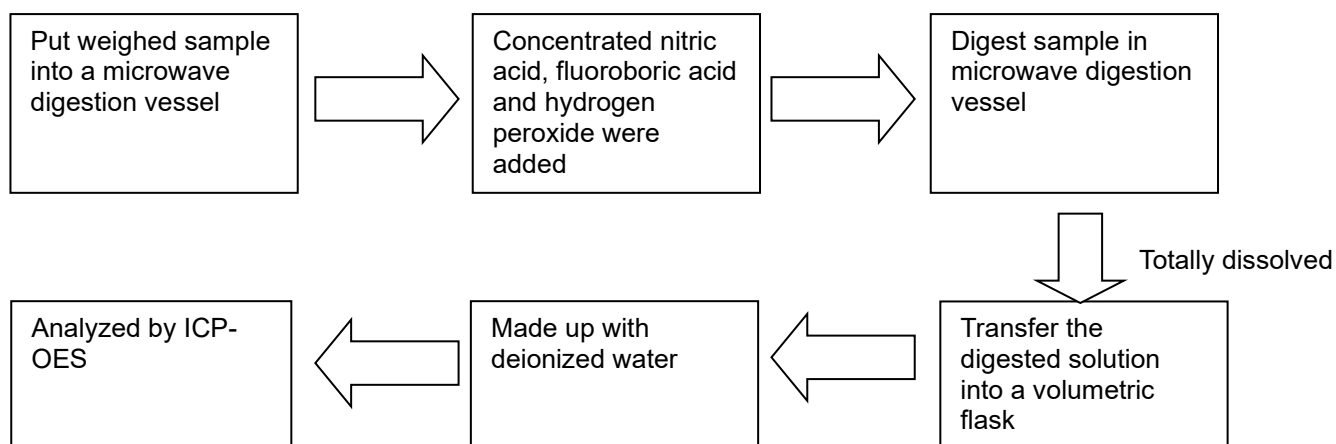

2. Test for Hg Content









5. Test for Phthalate Contents




